The financial up-gradation and consequent pay fixation will be subject to the terms and conditions stipulated in the DOP&'s O.M. No.35034/3/2008-Estt.(D), dated 19.05.2009 and further clarifications issued thereon in the matter.

There shall be no further fixation of pay at the time of regular promotion, if it is in the same grade pay in respect of above officers/officials as the promotions earned in the post carrying same grade pay in the promotional hierarchy as per Recruitment Rules shall be counted for the purposes of MACPs.

The financial up-gradation under MACP Scheme has been considered on the basis of references and recommendations received from the respective Institute. Therefore, it is assumed that the provision of consequential effect for grant of 02nd /3rd financial up-gradation under MACP/ACP Schemes, where financial up-gradation was deferred/postponed, in the past have been taken note of while sending the proposals to this office.

In the event of any overpayment as a result of financial up-gradation under MACP Scheme, if pointed out by the Audit or as a result of subsequent Government instructions/orders, the same shall be recoverable from the officer/official concerned.
